Welcome to the 2024-2025 school year! I hope you had a wonderful summer. I am writing not only to welcome you to the new school year, but also remind you of program of study opportunities and information available on the district website.

Programs of Interest include career academies, advanced academic programs, Junior Reserve Officer Training Corps, and the Arts. For most programs, the application process is tentatively set to begin on January 6, 2025, and to end January 31, 2025, for the 2025-2026 school year. More information is available at https://cte.stjohns.k12.fl.us/programs//. It is never too early to begin consideration of your child's future educational goals.

Virtual options are available either during the regular school day or after school and in the summer. All virtual course requests must be approved by a guidance counselor. The next open enrollment periods to apply for St. Johns Virtual School as a full-time student are November 1 - December 6, 2024, and in the spring, April 11 - July 11, 2025. To learn about all virtual options, please go to http://www-sivs.stjohns.k12.fl.us or call 904-547-8080.

All St. Johns County schools offer Academically Challenging Curriculum to Enhance Learning (ACCEL) options, which look different at each level. Options include but are not limited to:

- Middle high school courses in middle school; virtual instruction in a higher grade-level course; qualifying students may even participate, at no cost to them, in Dual Enrollment with St. Johns River State College and FCTC. ACCEL options do not supersede the core course requirements for promotion to high school (three English language arts, three math, three sciences, and three social studies) but courses taken in middle school may earn high school credit (1003.4156 F.S.)
- High college credit via Advance Placement (AP), Advanced International Certificate of Education (AICE) or International Baccalaureate (IB) exams, Dual Enrollment (DE) in St. Johns River State College or Career Dual Enrollment (CDE) in First Coast Technical College courses that meet high school graduation requirements and earn college credit at the same time; high school credit by passing the state End-of-Course (EOC) assessments for selected courses; virtual instruction in advanced courses; early graduation; college credit by passing the College Level Examination Program, (CLEP) assessment for a college course or an AP exam without actually being enrolled in the course. Also, industry certifications earned while in high school may articulate for college credit. When considering an academic path keep in mind that there are several diploma options. Designations are dependent upon a student's course of study. Details regarding the criteria for each option and graduation requirements by cohort year are available at https://www.fldoe.org/schools/k-12-public-schools/sss/graduation-requirements/.

Planning should include post-high school goals. After high school, students may qualify for the Florida Bright Futures Scholarship Program. To find out how to qualify for this Bright Futures Scholarship go to https://www.floridastudentfinancialaidsg.org/SAPHome/SAPHome?url=home. Also, industry certifications earned while in high school may articulate for college credit. Students in grades 6-12 will have five hours of required instruction on substance use and abuse, child trafficking prevention and awareness, and mental and emotional health education (Rule 6A-1.094124, F.A.C.). Students in grades 7-12 will be required to receive instruction on healthy relationships per section 1003.42 (2)(n), Florida Statutes and also on the DOE website https://www.fldoe.org/schools/healthy-schools/comprehensive-health-edu.stml. These are important topics that will help our students have the knowledge and ability to act when faced with difficult situations. I believe this instruction will be extremely beneficial for your children and/or reinforce what is taught at home. The required instruction for grades 6-12 will be led by teachers utilizing evidence-based, high-quality instructional materials infused in monthly Character Chats videos created by district staff.

The St. Johns County School District (SJCSD) is committed to safety, security, and the health and wellbeing of all students. Each St. Johns County school has an Emergency Operations Plan with incident specific procedures that is reviewed and practiced regularly. Our school district also works closely with local public safety officials using their expertise and input. Regular safety, health, security, and fire inspections take place each year in all schools. School Health Services contributes to the goals of the education system by helping to ensure that all students are healthy and ready to learn. With a nurse in every school, they function as a part of the school's team to bridge the gap between health, wellness, and learning. Per F.S. 381.0056 - School Health Services Program, school nurses work with parents, other health professionals, and school staff to provide services. For a list of services offered in school clinics and additional information, please visit the Health Services website at https://www.stjohns.k12.fl.us/health/. Most schools have also been designated as shelters to be used in the event of a hurricane or other emergency requiring temporary shelter. Each school has a Safety Committee and Threat Assessment Team as well, that meet regularly to discuss issues of safety and security.

A Youth Resource Deputy (YRD) is assigned at every school. The YRD participates in the facilitation of required training, drills, and on the school's Threat Assessment Team. As prescribed in State Board of Education Rule 6A-1.0018, Active Assailant Response drills will be conducted four times each year. YRDs will also meet with students and facilitate age-appropriate discussions in the beginning of the school year focusing on Active Assailant Response procedures, the "Always Rules" and Safe Zones in the classrooms. The PowerPoint presentation for these can be viewed at https://www.stjohns.k12.fl.us/schoolservices/safety/. In addition, we will practice fire, tornado, AED response and bomb threat drills for all faculty/staff and students throughout the year.

Over the past few years, we have enhanced and added several security measures at our school sites. Our camera systems are actively integrated with the Sheriff's Department for their viewing during a critical incident and we have implemented a Mobile Panic Alarm System (Centegix) that gives all school staff members the ability to lockdown a school as well as send notification to the Sheriff's Department's 911 Dispatch Center. We also have 800MHz radio capabilities at all schools to directly communicate with local law enforcement in emergency situations. FortifyFL continues to give all our students and families a reporting tool where they can share threats to school and district staff. This can be downloaded from any app store. Students will receive instruction on proper use. School site risk assessments continue to be

Patrick Canan District 5 conducted annually and many of our building safety initiatives such as single point of entry, electronic access, perimeter fencing, and increased signage were completed in alignment with these assessments.

As required by Florida Statute 553.865(4), schools are to maintain separate restrooms for the exclusive use of males and females, or unisex restrooms as defined by Florida Statute 553.865(3)(m). No person (student or adult) on our campus may use restrooms designated for members of the opposite sex.

Visitor and volunteer sign-in procedures are required in each school and all schools use the Keep 'N Track sign-in system. We require all visitors and volunteers to sign in and wear badges when visiting the school. All visitors and volunteers must submit a School Access Application in which a background check by the Sheriff's Department and a 50-state sexual offender check is completed before applicants are approved for school access.

To communicate with parents in a crisis, our mass communication system is used. This system provides any combination of instant telephone, text and email communication for emergency, community outreach, special events and other school/district messages. If at any time you have concerns about the safety of your child or issues concerning safety or security, please call your child's school.

Measuring the Economic Success of Florida's Graduates 2022 Economic Security Report Summary

Outcomes




Figure 1. Median First- and Fifth-Year Earnings by Credential

Florida has an extensive postsecondary higher education system—a system that provides students access to a world class education. To ensure Florida's postsecondary higher education system is well positioned for the future, the Florida Legislature created the *Economic Security Report* to provide students, parents, and others with information on graduates of Florida's public postsecondary institutions of higher education, which include the District Technical Centers (DTC), the Florida College System (FCS), and the State University System of Florida (SUS). Figure 1 below shows the first- and fifth-year earnings outcomes by type of credential for over 1 million graduates who completed their credential over the 5-year academic period of 2015-16 through 2019-1920. The figure highlights that earnings increase with each step along the education ladder.


In addition to earnings outcomes, we also look at the number of graduates by credential. Figure 2 shows the number of graduates over the same five-year period, which indicates that the associate and bachelor's degrees are the most awarded postsecondary credentials in Florida (68%). In addition, a significant number of students graduated from a certificate, diploma, or apprenticeship program (22%), while graduates from advanced degree programs represent the smallest group of total graduates (10%).

Debt

Student debt is a growing concern nationwide. Totaling more than \$1 trillion, student debt now surpasses outstanding credit card debt and automobile loans and is second only to home mortgages. Many students default on their loans, and because student loans cannot be discharged in bankruptcy, the consequences of accumulating debt that cannot be paid off can be long-term and financially devastating. The average statewide federal loan amount per student at Florida's postsecondary higher educational institutions was approximately \$5,862 (this amount is averaged across all students that received federal student loans and does <u>not</u> include private loans or other debt issued by non-federal government sources).

Labor Market Demand

The earnings that graduates command are not only a function of the programs from which they graduate, but also of the strength of the labor market into which they enter. The top three industries that expect to add the most jobs in Florida over the next eight years are professional, scientific, and technical services (128,315 jobs); food services and drinking places (84,293 jobs); and ambulatory health care services (82,175 jobs). With projected growth in these three industries estimated between 10% to 19%, these industries are expected to add over 290,000 new jobs to Florida's economy between 2022 and 2030.

Progress

The median first year earnings of graduates can be compared across the five academic years from 2015-2019. In general, median first-year salaries have increased steadily. Among Florida's public postsecondary educational systems, the Florida College System (FCS) has the highest percent growth in median first year earnings followed by advanced technical certificates.

Nut Awareness

We have students within our school population that have severe nut food allergies. It is important that they strictly avoid this food in order to prevent life-threatening allergic reactions that require emergency medical treatment. To reduce the chance of this occurring, we are taking steps to provide them with a school environment that is as safe as possible. Those steps are as follows:

- Each classroom is Nut Aware to avoid exposure when possible. Individual teachers will be in contact with you if a student with severe allergy is in your student's class.

Things you can do to help the school be Nut Aware:

- If your child has eaten any nut butter before coming to school, please be sure your child's hands and face have been thoroughly washed before entering the school. It is important that nut residue is not on a child's hands when they handle common schoolbooks and equipment.
- Avoid sending nut products to school when possible. Minimizing the number of these
 products in the school environment will decrease the risk of exposure. All treats must
 be store bought.

We understand that avoiding nuts can be difficult; we have provided helpful snack suggestions and a link to a food list on this page. This is not a comprehensive list and these snacks change frequently. If unsure about a particular food item, please email your classroom teacher. Thank you so much for your prompt attention to this very important matter.



Procedure for School Access

As required by Florida state law, everyone MUST have a cleared background check to go past the front office at Pine Island Academy. Picture ID (driver's license) is also required to enter the building at all times. You MUST have school access approval to volunteer at the school, attend any conferences or chaperone field trips.

Now is the time to go ahead and apply for school access if you have not already done so! Please make sure all spouses, grandparents, siblings over the age of 18, etc. who may visit the school are also approved to enter the building. The school access application is online at

The cleared application is good for 3 years and can be updated in the front office or renewed at any time. At no time should you have to resubmit another application.

The front doors will remain locked during school hours. Front Office personnel will request visitors state the nature of the visit before the doors will be unlocked. If there are multiple visitors, all visitors will need to respond before being able to enter. We appreciate your patience and understanding as the safety of our students is paramount.



Be informed about the health risks involved in the use of recreational and performance-enhancing drugs, tobacco and alcohol, as well as eating disorders.

❖ Fairness and Openness- Live up to high standards of fair play. Be open-minded, always be willing to listen and learn.

- Concern for Others- Demonstrate concern for others. Never intentionally injure any player or engage in reckless behavior that might cause injury to yourself or others.
- ❖ Teammates- Help promote the well-being of teammates through positive counseling and encouragement, and by reporting any unhealthy or dangerous or illegal conduct to a school authority (coaches, administrators, teachers, etc.)

CITIZENSHIP

- Playing by the Rules- Have a thorough knowledge of and abide by all applicable game and competition rules. Demonstrate and demand integrity.
- Spirit of Rules- Honor, observe and enforce the spirit and the letter of rules.
